the "State of the District" address. Among the highlights was the district's new \$44 million energy performance contract, the largest of its kind in New York State history.

The 18-year GESPC will save the District \$2 million a year by replacing 44 boilers, all the windows and doors at Mount Vernon High School, and installing new controls for room temperature and LED lights, among other improvements.
